

Job Title: Animal Care Team

Location: Georgia Safari Conservation Park

Job Type: Full-Time (Hourly)

Job Summary

The ideal candidate is knowledgeable about the basic husbandry needs of the collection and performs daily care. This position could be considered supervisory based on experience and could be responsible for training Animal Care Professionals, Animal Care Aides, as well as future interns, docents, and volunteers.

Essential Duties and Responsibilities

***The following duties are normal for this position. The omission of specific statements of the duties does not exclude them from the classification if the work is similar, related, or a logical assignment for this classification. Other duties may be required and assigned.*

- Responsible for the assigned Animal Care team routine (Pasture, Barn, or Ambassador)
 - Including program coordination, design
 - Basic animal care
 - Including reptiles and small mammals (potentially birds)
 - Preference given to applicants with megavertebrate experience such as rhinos and giraffe.
- Regular and dependable attendance
- Ability to lift 40lbs unassisted, navigate uneven ground, bend over, drive and ride in off-road vehicles, work in all weather conditions including extreme temperatures, etc. as the job requires.
- Effective communication with Supervisor regarding professional and animal-related needs.
- Effective leadership and accountability skills
- Assist veterinary team with preventative and emergency care tactics
- Assist various GSCP teams as needed
- Willing to guide and engage reserved tour groups for animal-related programs as needed
- Sound decision making and ability to adapt as situations arise
- Work scheduled weekends, holidays, variable work weeks as needed.
- Collaborate with the Senior Management to create a safe, positive, compassionate, and healthy work environment.

Desired Qualifications

- Minimum of 6 months relevant experience required for entry level.
- Degree in Biology, Zoology, Education, or related field or 5+ years experience including a minimum of 1.5 years in a supervisory capacity if specialist position is desired.
- Ability to utilize various programs such as ZIMS, Microsoft Office Suite.
- Experience in designing and implementing SOPs, routine staff/volunteer training guidelines, risk assessments, and safety procedures. Documents and procedures require collaboration and review by Animal Care management. Training available.

Preferred Knowledge, Skills and Abilities

- Detail and observation oriented with a strong affinity for up to date and accurate record keeping.
- Ability to lead and inspire colleagues, guests, and volunteers.
- Ability to live within a 45-minute commute of the Park.
- Motivation to continuously grow within the position and the field; Continuing Education opportunities will be made available. (Relevant workshops, conferences, webinars, etc. will be considered)
- Ability to operate Kawasaki Mules, Golf Carts, assorted touring vehicles, etc.
- Heavy machinery experience is a plus (tractor, skid-steer, etc.); training available.
- Collaboration in collection planning inclusive of educational, conservation, and management needs.
- Able to communicate effectively, both orally and in writing.

Additional Requirements

- Successful completion of a post-offer background check, including criminal and driving records.
- Employees will be employed for a ninety (90) day probationary period.

Physical Demands

While performing the duties of this job, the employee must be capable of:

- Standing, walking, or sitting for long periods of time (approximately 100% of their assigned shift); ability to climb stairs, bend, and stoop during the execution of duties.
- No significant uncorrected impairment of visual or auditory ability.
- Ability to lift and carry a weight up to fifty-five (55) pounds.
- No allergies related to plants or animals that would interfere with the ability to work.
- Ability to work in both indoor and outdoor environments and in all weather conditions.

Performance of essential functions may require exposure to adverse environmental conditions, such as angry/hostile employees.
